**RIIL FINANCE COMMITTEE REPORT AND APPOINTMENT**

Mr. Lunney reported on the Finance Committee meeting held on August 19, 2024. The RIIL is in the process of finishing this year's independent audit. Insurance renewal quotes have been received including the addition of middle schools. Also, Mr. Stuart Peterson of Janney provided the Committee with an RIIL update on investments.

**EXECUTIVE DIRECTOR'S REPORT**

Mr. Lunney reported on the following:

### **MIDDLE SCHOOLS**

Mr. Lunney reported on the middle schools planning update regarding fall schedules, championships, assumption of risk form and new initiatives. The Committee had a brief discussion regarding a rule revision to Article 3. Eligibility, Section 5.B.2. Length of Eligibility. The rule revision was tabled for further consideration.

In addition, a Middle School Sport Sub-Committee has been created and will serve as a committee for issues concerning middle school students. ### **RIIL RULE REVISIONS**

#### **Article 22, Section 1. – Ice Hockey**

On a motion made and seconded, the Committee unanimously (13-0) approved a rule revision to Article 22, Section 1 – Ice Hockey to add “*a maximum of 23 players, including goalkeepers, may dress for and play in a game.*”

### **RIIL SPORTS MEDICINE ADVISORY COMMITTEE (SMAC)**

Congratulations to Burrillville HS, Janita Sanchez Educational Complex, Lincoln HS, Mt. Hope HS, South Kingstown HS, Westerly HS and West Warwick HS. All seven (7) schools were randomly selected to receive an AED for their athletic programs! In addition, the RIIL received two (2) for our championship events. AED donations were funded by the RIIL and a grant from the NFHS. Pre-season practice limitation will be discussed at the next SMAC. Mr. Lunney gave an update on the use of Guardian Caps in football. Also, the NFHS and RIIL strongly encourage the use of the pre-game medical time-out protocols to ensure that coaches, officials, game management and medical personnel coordinate emergency action procedures.

### **REQUESTS FROM SCHOOLS**

The RIIL received a request from Segue Institute for Learning – Legacy High School to join the League under Article 3, Eligibility, Section 2, Alternative Education (Charter) School Athletic Participation beginning with the 2024-2025 school year. On a motion made and seconded, the Committee unanimously (13-0) approved their request.

The RIIL received a request from Mrs. Laura Twitchell, Head of Upper School at Moses Brown School, Mrs. Sue Farnum, Head of Upper School at Lincoln School and Mr. Kevin Folan, Head of School at Providence Country Day requesting a waiver of Article 7, Section 4.C, Limitation of Seasons rule regarding the start date of spring sports for the 2025 spring season. After discussion, on a motion made and seconded, the Committee unanimously (13-0) denied the request.

### **OFFICIALS**

Mr. Lunney reported that the RIIL has been working with the officials’ organizations and sport committees during the 2023-2024 school year regarding the new agreements which will take effect beginning with the 2024-2025 school year.

**RIIAAA REPORT**

Mr. Lunney requested, in support of ongoing education efforts for athletic directors, a grant of \$1,000 be given to the RIIAAA to cover the cost of Leadership Training Courses (LTC) offered by the NIAAA. The RIIAAA will use the funds to offer NIAAA courses 501, 502 and 503 in an effort to provide ongoing professional development opportunities for member athletic directors. On a motion made and seconded, the Committee unanimously (13-0) approved the request.

**FALL SPORTS**

The first day of practice for football begins August 15, 2024. All other high school fall sports begin on August 19, 2024. The first day of practice for middle school sports is August 26, 2024. Mr. Lunney reported the RIIL has been securing championship venues for the fall championships.

**WINTER SPORTS**

The winter sports schedules have been sent to all member schools and posted online. The first day of practice for high school sports begins December 2, 2024. The first day of practice for middle school sports is November 18, 2024. Mr. Lunney reported the RIIL has been securing championship venues for the winter championships.

**SPRING SPORTS ALIGNMENTS**

Mr. Marcello presented the spring 2025 & 2026 softball and baseball alignments to the Committee on recommendations from the softball and baseball sport committees and endorsed by the RIIAAA. On a motion made and seconded, the Committee unanimously (13-0) approved softball sport alignment for spring 2025 & 2026. On a motion made and seconded, the Committee unanimously (13-0) approved baseball sport alignment for spring 2025 & 2026

**REQUEST FROM SCHOOL RULE VIOLATION**

The Committee held a virtual meeting on August 13, 2024 to discuss an allegation of a potential rule violation. After discussion, on a motion made and seconded, the Committee unanimously (13-0) voted to take no action.
